Reorganization Meeting

STATEMENT:

PUBLIC NOTICE of this meeting pursuant to the Open Public Meetings Act has been given by the Riverside Township Committee in the following manner:

3. Filed written notice with the Clerk of the Township of Riverside on December 21, 2007.

Meeting opened with prayer by Father Hillary from St. Casimir's Church.

The first order of business was administering the oath of office to Mr. Robert Prisco by Burlington County Clerk Philip Haines.

The next order of business was the appointment of a Chairman for the year 2008. Susan M. Dydek, Municipal Clerk, called for nominations of a Chairman for the year 2008. Mrs. Hatcher nominated Mr. Conard. **Hearing no further nominations, motion made by Mr. Polino, seconded by Mrs. Hatcher to appoint Mr. Conard as Chairman for the year 2008 carried. Mr. Conard be appointed Chairman (Mayor) for the year 2008, and assumed the chair.**

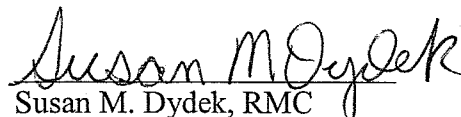
